→ Congress Passes Housing Reform Bill with Rare Bi-Partisan Support

On February 2, the House of Representatives passed H.R. 3700, the Housing Opportunities Through Modernization Act, by a vote of 427 Yeas to 0 Nays. This overwhelming show of support is the result of years of strong advocacy pushing these common sense reforms. Thank you to all advocates who contacted your Representative in the past few days about this important bill!

Prior to passage, H.R. 3700 was improved through the passage of several key amendments.

Changes to the bill include the following, all of which passed by voice vote:

- Amendment from Representative Maxine Waters (D-CA) to retain current law related to the standard \$480 deduction from income for dependents, as well as for all child care costs, that public & assisted housing residents may take before their rents are calculated.
- Amendment from Representatives David Price (D-NC) and Robert Aderholt (R-AL) to update the
 formula for HUD's Housing Opportunities for Persons with AIDS (HOPWA) program to count people
 living with HIV/AIDS as well as require HUD to develop regulations that incorporate a poverty factor
 and a housing cost factor in the updated formula. Currently, HOPWA funds are distributed based on
 cumulative AIDS cases, representing individuals both living with and dying from AIDS. AIDS housing
 advocates have been working for years to update the formula.
- Amendment from Representative Peter Welch (D-VT) to allow housing choice vouchers to cover costs
 beyond the rental of the land underneath a manufactured home, including helping the manufactured
 homeowner pay for the cost of their home, its insurance, utilities, and property taxes.
- Amendment from Representative Grace Meng (D-NY) to require HUD to publish model guidelines for minimum heating requirements for units operated by public housing agencies.
- Amendment from Representative Terri Sewell (D-AL) to require HUD to conduct a study of the impacts of H.R. 3700's income deduction changes on rents paid by the elderly, people with disabilities, and families.
- Amendment from Representative Sheila Jackson Lee (D-TX) to direct the Secretaries of HUD &
 Department of Labor to produce an annual report on strategies to strengthen family economic
 empowerment.

Other amendments: An amendment from Representative Keith Ellison (D-MN) to authorize HUD housing providers to report ontime rental payment to credit reporting agencies failed by voice vote during floor debate. The only amendment to receive a roll call vote was Representative Steven Palazzo's (R-MS) effort to permanently exempt all public housing agencies in Mississippi, lowa, Alaska, as well as the Housing Authority of the County of Los Angeles, from the requirement to have a resident on their boards of commissioners. This passed by a margin of 246 Yeas to 178 Nays.



Housing Mobility: A Chance for Families to Succeed

Recent <u>studies</u> on "neighborhood effects" and events in Baltimore and beyond have brought national attention to the plight of families living in poor, segregated neighborhoods.

In a new blog post, Rachel Brash of the <u>Baltimore Regional Housing Partnership</u> (BRHP) discusses her organization's housing mobility program that helps Baltimore families living in concentrated poverty move to better neighborhoods. Brash also explores the emerging research and federal regulations that have helped propel housing mobility initiatives into the national limelight.

An excerpt of Brash's piece: Although housing mobility is widely seen today as an effective way to use housing policy to break cycles of intergenerational poverty and improve quality of life for low-income families, this has not always been the case. Acceptance of this approach has been hard-won through years of experimentation, research, and increasing public awareness of the adverse effects of concentrated disadvantage and housing segregation. **Read More**

→ Tacoma planning

The City is currently developing a Subarea Plan and EIS for the Tacoma Mall Neighborhood. The effort will result in a plan and implementation strategies to achieve local and regional goals for the neighborhood, as well as up-front environmental approval for future development that is consistent with the plan. The study area is 601-acres, including the current 485-acre Center and a proposed 116-acre expansion area.

Between July and November 2015, the City conducted a major public and stakeholder engagement effort, including multiple public meetings and events culminating in a multi-day Design Workshop. Since that time, the project team has worked to assemble and analyze data, synthesize public input, and identify strategies to meet community objectives for the neighborhood. Several new documents are available on the project webpage, including summaries of public comments to date, of the EIS Scoping process, and of the September Design Workshop. The project is now entering a new phase. From February to June 2016, the City will build on this work to develop the Draft Plan and Draft EIS. This phase will include a second focused effort to engage the community.

Public meetings will be scheduled for March through May 2016.
