On Monday 01-21, the House Capital Budget committee heard testimony on the Housing Trust Fund. Specifically, they heard that it improves children's educational achievements; helps seniors living on fixed incomes; provides stable, supportive homes for individuals with disabilities; and is a key component in our effort to end homelessness. They also heard that it creates jobs and stimulates local economies.

By taking action today, you can reinforce those messages. It's still early in the legislative session. Many lawmakers are still sorting out what will be their top priorities and want to know what their constituents value most. Please take two minutes today to ask your lawmakers to support a \$175 million investment in the Housing Trust Fund.

→ Strong Public Policies are Essential in a Weak Economy

In an economy that is not working, children and families in Washington state need strong


social and economic policies more than ever.

Strong public programs are a cornerstone of a strong economy, and are a major reason why the recent downturn did not become another Great Depression. In 2011 alone, policies like the State Nutritional Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF), Earned Income Tax Credit (EITC), and Unemployment Insurance (UI) kept 40 million people in the U.S. out of poverty.

Washington state's most <u>recent employment report</u> shows that there still aren't enough jobs being created, and that the slight drop in the most recent unemployment rate is largely due to people who have given up looking for work. The jobs data look grim – 18 of the top 20 occupations with the most vacancies in Washington state do not pay enough for a family of three to even meet basic needs (see graph below).

The lack of jobs – especially those that pay enough to get by – is one of the main reasons for Washington state's declining middle class and increase in poverty. One in three kids in our state lives in a low income family, which does not bode well for their future or our collective well-being as a state.

As the Legislature debates a new budget this session, policymakers should keep in mind that investments in programs that help families find or keep a job and keep children out of poverty are essential to improving the overall economy.
