The Senate released their budget yesterday at noon, a plan that would increase homelessness & ensure that fewer people than ever have an opportunity to live in a safe, healthy, affordable home.

- Eliminates the Aged, Blind, Disabled cash grants for Washington's most vulnerable, starting in July
- Appears to also significantly cut HEN, possibly as much as 50%
- Housing Trust Fund is at risk of receiving no allocation

We are also hearing that the House is under extreme pressure to <u>not</u> include <u>any</u> allocation for the Housing Trust Fund in their budget next week either. The Housing Trust Fund is at more risk right now that it ever has been.

### Mortgage Interest Deduction (MID) Reform Legislation Introduced

On March 15, Representative Keith Ellison (D-MN-5th) introduced the <u>Common Sense Housing Investment Act of 2013</u> (H.R. 1213), which would repeal the mortgage interest deduction and replace it with a 15 percent flat-rate tax credit. Converting the mortgage interest deduction into a credit is estimated to provide a tax benefit to 16 million additional homeowners.

- Lower the cap on the amount of mortgage for which interest can be deducted from \$1 million to \$500,000; allow home equity loans and second homes under the \$500,000 cap.
- Convert the mortgage interest deduction to a 15% non-refundable mortgage interest tax credit.
- Phase in the two changes above over five years.
- Direct \$109 billion in savings to the National Housing Trust Fund over 10 years.
