Funding → The **City of Tacoma** is accepting proposals for the provision of **Displaced Tenant Relocation Assistance Services** by private, nonprofit organizations and/or government entities. These funds, in the amount of \$25,000 will be available for one year, starting July 1, 2010. Applicants must meet all minimum qualifications in order to submit a proposal and provide documentation of eligibility in the proposal packet.

State Advocacy → Support Washington Initiative I-1098! The Consortium is supporting the campaign to change the state tax structure. I-1098 would authorize a state income tax on high earners (\geq \$200k/individual & \geq \$400k per couple), concurrently cut property tax in the state by 20%, and increase the B&O tax exemption so that about 80% of businesses in WA will not pay B&O tax. The AHC Board has also endorsed a position of NO on I-1053, Tim Eyeman’s initiative to make I-960 a permanent requirement for a super-majority (67%) legislative vote to increase any taxes.
